1. *Phidim Municipality* invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of *Pauwa Bhanjyang-Ithung-Gurase -Chhatare Veer-Fulpa-Jalpa Bhanjyang-Singare Panchami Ringroad Sadak Khanda Nirman* under National Competitive Bidding procedures. The estimated amount for the works is Rs. 1,35,00,000.00 [Inclusive VAT].

A complete set of Bidding Documents may be purchased from the office of *Phidim Municipality* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of *Nrs. 3,000* till *20th May 2019* during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at *Office of Phidim Municipality* at *10th May 2019 13:00 Hrs.*
5. Sealed or electronic bids must be submitted to the office of *Phidim Municipality* by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 Hrs on *21st May 2019*. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at *13:00 Hrs 21st May 2019* at the office of *Phidim Municipality*. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of *Nrs. 3,37,500*, which shall be valid for 30 days beyond the validity period of the bid (i.e. *21st Sept 2019*)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
